Effect of Chronic Exposure:	<p><u>Skin Contact:</u> May cause skin irritation. Sodium selenate may cause eczema.</p> <p><u>Inhalation:</u> Inhalation exposure is unlikely. May cause respiratory tract irritation.</p> <p><u>Ingestion:</u> May irritate.</p> <p><u>Other Health Effects:</u> Over exposure to ivermectin, symptoms may include increased activity, slow rate of breathing, dilation of the pupils, muscle tremors and in coordination.</p> <p>Adverse effects may include abdominal pain, diarrhoea, nausea, vomiting and hair loss. NOTE: Pregnant females should not be exposed to dust and mist. Animal studies show teratogenic effects in rats and rabbits at doses of 10mg/kg/day albendazole during the first half of pregnancy.</p> <p>In a chronic study in rats given doses of 20mg/kg/day, albendazole produced slightly reduced leukocyte and neutrophil counts. In mice, degeneration of tubular epithelium of testes was observed following chronic dosing of 400mg/kg/day albendazole. Administration of doses of 10mg/kg/day albendazole for one month in humans receiving treatment for parasitic infestation has resulted in reversible abnormalities in liver function tests.</p>
